1. Introduction

The Faculty of Management, Economics, and Social Sciences (WiSo-Faculty) in Cologne is

the largest and best reputed faculty of its type in Germany. It has a strong tradition in both

fundamental and applied research in the covered disciplines.

The faculty and the University have been very successful in the academic year 2011/2012.

The University has been granted the status of a University of Excellence, in a national

contest where only 11 Universities have been successful. In its proposal, the University

identified four "University of Cologne Competence Areas", one of which, "Social and

Economic Behavior" is strongly based on research undertaken at our faculty.

In 2012 the WiSo-Faculty became accredited by EQUIS, a well known international

accreditation for business schools, which only four German Universities can exhibit. In the

EQUIS evaluation, the portfolio of research and development activities was judged to be

"above standard".

In October 2011, the research group, "Design and Behavior - Economic Engineering of

Firms and Markets" was inaugurated. Researchers from economics and business

administration as well as psychologists study the design of real-world institutions and

mechanisms based on behavioral research.

This report documents research news, general information about the research activities of

the members of the WiSo-Faculty and their research output, i.e. publications by members of

the Faculty, conference presentations by PhD students and Postdocs of the WiSo-Faculty

and completed PhD theses in the academic year 2011/2012.

2. Research-Related News/General Information

2.1 News from the Faculty

- In June 2012, the University of Cologne was awarded the status of a University of Excellence by the German Research Foundation (DFG). The institutional strategy to advance the University of Cologne "Accepting the Challenge of Change and Complexity" was approved by the DFG in the second phase of the Excellence Initiative. The strategy aims at strengthening and further developing the university's research profile, at establishing funding programs for cutting edge research and at integrating new career-promoting structures and support measures. One of the four university's key profile areas ("Behavioral Economic Engineering and Social Cognition") is headed by Axel Ockenfels.
- In April 2012, the WiSo faculty received the EQUIS seal of approval by the European Foundation of Management Development (EFMD). In addition to the University of Mannheim, the WiSo faculty is the only federally funded university in Germany that is EQUIS accredited.
- The official inauguration of the research group "Design & Behavior" was held on October 11, 2011. Professor Peter Cramton (University of Maryland), one of the leading experts in the area of auction and market design, gave a speech on "Market Design - Insights from Practice".
- Detlef Buschfeld has taken over as vice-dean for teaching, academic studies and reform, a position previously held by Bernadette Dilger.
- After six years, first as faculty appointee for research and then as vice-dean for research and young academics, Achim Wambach will step down in September 2012. He will be followed by Bettina Rockenbach.
- Axel Ockenfels has been appointed a Contributing Author in the Intergovernmental Panel on Climate Change (IPCC).
- Dirk Sliwka was elected by "Personalmagazin" as one of the top 40 persons at human resource management.
- Achim Wambach has been appointed chairman of the academic advisory board of the Federal Ministry for Economics and Technology in May 2012.

FiFo Institute for Public Economics

- Prof. Dr. Alexander Ludwig took up a directorship at the institute in July 2012.
- FiFo has continued to contribute to policy analysis and design in various action fields of public economics. In the course of the academic year 2011/12, FiFo has been working on reports and studies for five different federal ministries (Finance, Economics, Environment, Family Affairs, and Education/Research), the state governments of North Rhine-Westphalia, Bavaria and Rhineland-Palatinate, and partners on the local as well as on the international level.
- In July 2012, FiFo won the prestigious contract to evaluate and remodel the system of fiscal equalization in North Rhine-Westphalia, thus breaking an ifo-Munich research monopoly of almost two decades. The fiscal equalization system directly determines the provision of local public services to 18 million people in the most populous German state.
- In cooperation with the University of Stuttgart, the Technical University Hamburg-Harburg and the Leibniz-Institute for Urban and Regional Development Dresden, FiFo continues to develop the large-scale micro agent- and policy simulation-model €LAN. When put in to practice by mid-2013, €LAN promises to establish itself as one of the world's most powerful urban simulation models.
- In June 2012, FiFo finalized its third in-depth evaluation of German budget transparency, thus participating in the renowned Open Budget Index, a Washington -based research initiative with a network covering more than 100 countries worldwide.
- FiFo's leading personnel intensively contributed to public policy debates by disseminating research findings in various interviews with print and Internet media, TV and radio stations. They also acted as invited experts for several committees of state parliaments and the German Bundestag.
- In late 2011, FiFo's managing director, Dr. Michael Thöne, has been confirmed as the chairman of the mixed policy-consulting team, the "Working Group on Public Economics", of the Federal Minister of Finance.

Institute for Broadcasting Economics

 As in Germany the present broadcasting fee will be substituted by a new household fee in 2013, several projects on "Long-term forecast of the broadcasting license fee revenues under current law and of the device-independent broadcasting household fee", funded by the Gebühreneinzugszentrale (Broadcasting Fee Association), have been completed in 2011.

- Also for the Gebühreneinzugszentrale a broad study about the methodological forecasting problems of the new household fee has been completed in 2011.
- At a conference of the "Netzwerk Medienstrukturen" in September 2011 Dr. Manfred Kops presented a study on "Methods for International Comparisons of Media Systems". The study will be completed in 2012.
- Dr. Olexiy Khabyuk has left the Institute by the end of 2011.
- Prof. Dr. Horst Schellhaaß will leave the Institute's directorship by the end of the summer term 2012.

Institute for Economic Policy (iwp)

- The iwp has started a long-term research project on the impact of federal legislation on the German small and medium size firm sector. The results of the first part of the project

 "Impact of state intervention to promote building restoration on the real estate market" have recently been published online.
- The IWP has continued the series called "Kölner wirtschaftspolitischer Dialog" in cooperation with the Handelsblatt. In summer term 2012, two dialogues took place: One between Sylvia Löhrmann (Minister for Education of the land NRW) und Prof. Dr. Ludger Wößmann (Ifo Institute Munich) on the topic "Education as location factor opportunities and limitations of competition" and one between Ursula Heinen-Esser (Parliamentary State Secretary of the Federal Ministry for the Environment, Nature Conservation and Nuclear Safety) and Prof. Dr. Andreas Löschel (Center for European Economic Research) on the topic "Enforceability of a sustainable climate policy within a democracy".
- In winter term 2011, the iwp has organized a lecture series on the European Monetary Union.

Institute of Energy Economics (EWI)

- EWI has had a significant research output in 2011/12, leading to more than 10 publications in refereed international journals.
- EWI has continued to contribute to the European and German energy policy debate with numerous studies and reports. In particular the study "Investigation into a sustainable electricity market design for Germany", commissioned by the Ministry of Economics and Technology (BMWi) was widely received and discussed.
- EWI has developed several new numerical models for simulating energy markets. DIMENSION is a long-run equilibrium model with endogenous investment for the (conventional and renewable) electricity market in the EU 27 plus Norway and Switzerland. TIMCO is a long-run equilibrium model that allows simulations of different evolutions of the global steam coal market, taking into account global interdependencies up to the year 2030. DIscrHEat (DIscrete choice HEat market simulation model), is a dynamic simulation model for private households within the German heat market.
- EWI has new staff members: Dr. Sebastian Kranz is a temporary Professor at the Institute of Energy Economics at the University of Cologne during the academic year 2011/2012. Sebastian Nick has joined as a research associate and doctoral candidate at the Institute of Energy Economics at the University of Cologne since February 2012. Melanie Tillmann has been a part of the Corporate Communications team since April 2012. Lastly, Dr. Helena Meier started as a Post Doc in July 2012.
- In January and August 2012, Prof. Steven Gabriel from the University of Maryland (USA) was once again a guest at the EWI. The mathematics and energy economics modeling

specialist is a researcher at the University of Maryland Energy Research Center (UMERC) and a professor of the interdisciplinary Master of Engineering and Public Policy (MEPP) program. Currently, EWI scientist Stephan Nagl is performing research at the University of Maryland for several months with the UMERC.

- In January and February 2012, Dr. Tim Mennel from the Centre for European Economic Research (ZEW) was a guest at the EWI.
- From June to August 2012, Ramona Miron from the Lucian-Blaga-University in Sibiu, Romania, was a guest at the EWI. Broghan Helgeson from Santa Cruz, CA, USA worked as an intern from June to September 2012. PhD student Dominique Pride from the University of Alaska Fairbanks (USA) also did an internship from June to August 2012.
- During 2012, EWI scientists Timo Panke and Johannes Trüby will work for several months at the International Energy Agency (IEA) in Paris.
- The 10th Annual EWI / F.A.Z.-Energy Conference took place at the 8th of September 2011 at the Gürzenich Cologne. Various speakers, including European Commissioner for Energy Günther Oettinger and Chairman of the Board of E.ON Ruhrgas AG Klaus Schäfer, debated on the future role of natural gas in the energy supply. The 11th Annual EWI / F.A.Z.-Energy Conference titled "Design for the Future Electricity Market" took place on the 25th of September 2012.

Institute for Retail Research (IFH)

In 2012, the board of the Institute for Retail Research commissioned a large scale study
on the topic of "Value Creation in the Retailing Sector". The first results of this study were
presented in September 2012. After last year's highly successful study on "The Retailing
Sector as an Employer", which was very well received by both employers as well as the
public press, the board wants to continue this approach of launching high impact studies
about the sector.

3. Research Output

In 2004 the WiSo Faculty implemented a budgeting system according to which the budget of each chair depends on the number of publications in high-ranking scientific journals. For this purpose, we defined A, B and C journals for each of the three subgroups, based on established journal rankings. A list of the journals is provided in section 4.3. In section 3.1 the publications in the academic year 2011/2012 are listed. It should be noted, however, that not all leading field journals belong to this list of journals. For example, some journals in psychology or statistics are not covered if they have little relation to economics or social sciences.

In addition, the budgeting system allocates money to chairs whose Ph.D. students and assistant professors present papers at prestigious academic conferences (see section 4.3). In section 3.2 the young researchers who obtained the funding and the corresponding conferences are listed.

In section 3.3 we provide a list of all Ph.D. theses, which were successfully completed in the academic year 2011/2012 at the WiSo faculty.
