## 1 Introduction

The Faculty of Management, Economics and Social Sciences (WiSo-Faculty) in Cologne is the largest and best reputed faculty of its type in Germany. It has a strong tradition in both fundamental and applied research in the covered disciplines.

One of the main characteristics and assets of the WiSo-Faculty is its large number of individually excellent researchers covering management, economics and social sciences. During the last year we successfully intensified collaborative research by identifying and promoting four research profile areas of excellence as a starting ground for future collaborative endeavours. In these research networks a critical mass of faculty gathered together addressing common research topics, jointly develop research ideas to advance cooperative projects and third party funding. Besides the already established DFG research unit Design and Behaviour and its adjacent projects three research networks on Value Creation in a Changing Customer and Media Environment, Behavioural Management Science and Demography and Social Inequality have been established. Further research networks are currently developing.

Research and its quality are notoriously hard to measure. As university management, governments as funding agencies and other actors in politics and academia are increasingly using competitive and performance-oriented policies, performance indicators of any kind become increasingly important. In this regard, the Handelsblatt Ranking and the Wirtschaftswoche Ranking attract high public attention for the fields of business administration and economics. In the 2014 Handelblatt Ranking the Faculty's research in business administration received rank 4 among the German universities. Five researchers from the business and management faculty were among the top 100 researchers. In the latest Handelsblatt ranking of 2015 for economics the Faculty received rank 4. Seven researchers from economics are listed for their life time achievement, six researchers in the ranking of the recent publications, and five among the top 100 researchers younger than 40 years. In the current 2015 ranking of the Wirtschaftswoche, business and management stabilized its rank 2, economics received rank 3 and Information Systems improved considerably from rank 8 to rank 2.

This report documents research news, general information about the research activities of the members of the WiSo Faculty and their research output, i.e. publications by members of the Faculty, conference presentations by PhD students and Postdocs of the WiSo Faculty and completed PhD theses in the academic year 2013/2014. The main task of this report, however, is to provide a general account of the WiSo-Faculty's activities during 2013/2014 and a detailed documentation of the institute's scientific activities.

## 2.8 News from the Research Institutes

### *Department of Information Systems*

- In 2014 the Department of Information Systems continued their successful Brown Bag Seminar series. The seminar serves as an open platform for sharing and advancing current research projects. The sessions are casual and interactive, allowing for presenter and audience to engage in discussion about the topic. The theme of the seminar covers all areas of information systems and is open for PhD students as well as national and international guest researchers. Between November 2013 and December 2014 the seminar welcomed eleven presenters from around the world, including Russia, Denmark, Germany, Australia, USA and the Netherlands.

### *Energiewirtschaftliches Institut, ewi*

- The ewi has been given a new organizational structure. Applied research has been relegated to a newly-founded charitable entity, ewi Energy Research & Scenarios. The remaining activities, in particular the support given to fundamental research in the Faculty, will be continued by the 'Institute of Energy Economics at the University of Cologne' which remains an 'An-Institut'. The two entities will closely cooperate in order to maximize the synergies between applied and fundamental research.
- Research output of the ewi has remained strong, in particular in the leading international peer reviewed journals in the field (in 2013-14: 5 publications in Energy Economics, 5 publications in The Energy Journal, the Journal of the International Association of Energy Economics, IAEE). In total, ewi researchers published 27 peer reviewed articles in 2013-14.
- Research programme and output has received a positive evaluation from ewi's research council.
- With more than 100 public appearances (live, recorded, in print) and several highly visible public studies, ewi's applied research output has continued to significantly contribute to the German and European debate about energy policy.
- The ewi and Felix Höffler have started cooperating with the Institute for Geophysics and Meteorology at the Uoc in the "Emerging Group" ET-CC (Energy Transition and Climate Change), funded from the university's "ZukunftsKonzept" in the "Exzellenzinitiative".
- In cooperation with F.A.Z., Frankfurter Allgemeine Zeitung für Deutschland, ewi hosted annual conferences in 2013 and 2014, bringing together more than 100 academic researchers and energy practitioners from industry and politics.

#### *Excellence Center for Social and Economic Behavior (C-SEB)*

- Several chairs at the WiSo faculty have collaborated to prepare the launch of the UoC Excellence Center for Social and Economic Behavior (Speaker: Axel Ockenfels | Website: c-seb.uni-koeln.de). For that purpose a symposium with internationally renowned experts from Economics and Psychology was held in November 2014. During the meeting, researchers from the UoC presented their concepts and strategies concerning the scientific focus of the center to the expert group. The final discussion brought helpful insights for the future development of C-SEB.

*Institut für Wirtschaftspolitik, iwp*

- The iwp research team intensively contributed to public policy debates by disseminating research findings in various interviews with print and Internet media, TV and radio stations.
- The iwp has continued the series called “Kölner wirtschaftspolitischer Dialog” in cooperation with Handelsblatt. In 2014, two dialogues took place: One between Günter Oettinger, EU Commissioner for Energy, and Prof. Dr. Marc Oliver Bettzüge, director of the Institute of Energy Economics at the University of Cologne. This dialogue dealt with the topic: “The German Energy Turnaround in the context of the European Climate and Energy Policy”. The second dialogue was between Svenja Schulze, Minister of Innovation, Science and Research of the federal state of North Rhine-Westphalia, and Prof. Dietmar Harhoff, Ph.D., director of the Max Planck Institute for Innovation und Competition on the topic: “The Responsibility of Science”.
- The lecture series, dealing with current topics in economic policy, has continued as an integral part of the winter term curriculum of the University of Cologne: In 2013/14, the lecture series was dedicated to the energy turnaround in Germany. In 2014/2015, it dealt with development policy against the background of the Post 2015 Development Goals.
- In 2014, the iwp organized the first training for teachers of the faculty. It dealt with present economic challenges giving teachers advice on how to integrate repetitive topics into their teaching.
- The iwp continues to expand its expertise in the field of real estate economics. In this context, another expert discussion round hosted by the iwp has taken place in September 2014. The discussion round dealt with the economic consequences of gentrification.

### 3 Research Output

In 2013, the Faculty abolished its AKMV budgeting system. The system tied the budget of each chair to the number of publications in high-ranking academic journals. Since then, the faculty documents its research record in absolute numbers of journal articles (peer-reviewed and non peer-reviewed), conference proceedings, working paper and further publications. This new format is used in various occasions, e.g. the EQUIS accreditation and the WiSo Evaluation.




#### 3.1 Publications in 2013/2014
